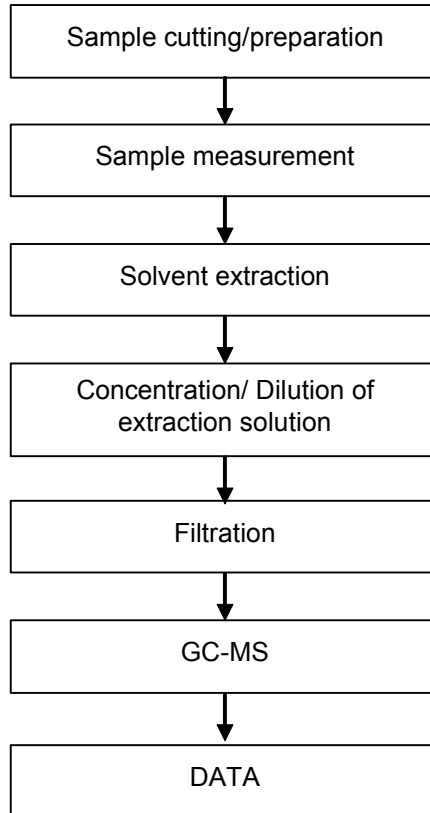

**PBBs/PBDEs Testing Flow Chart**

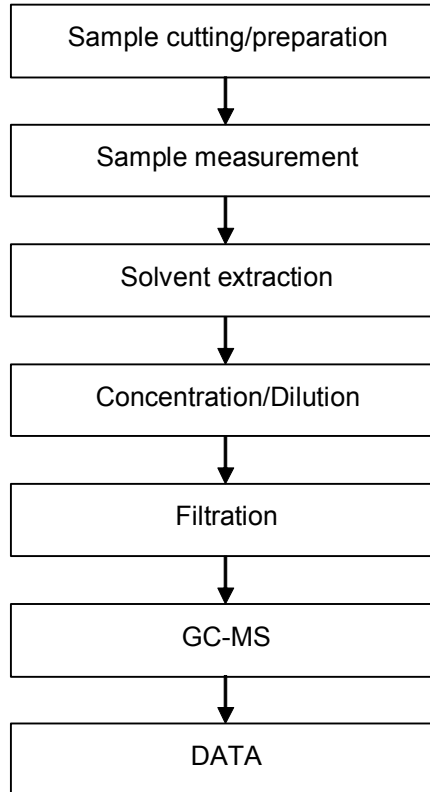

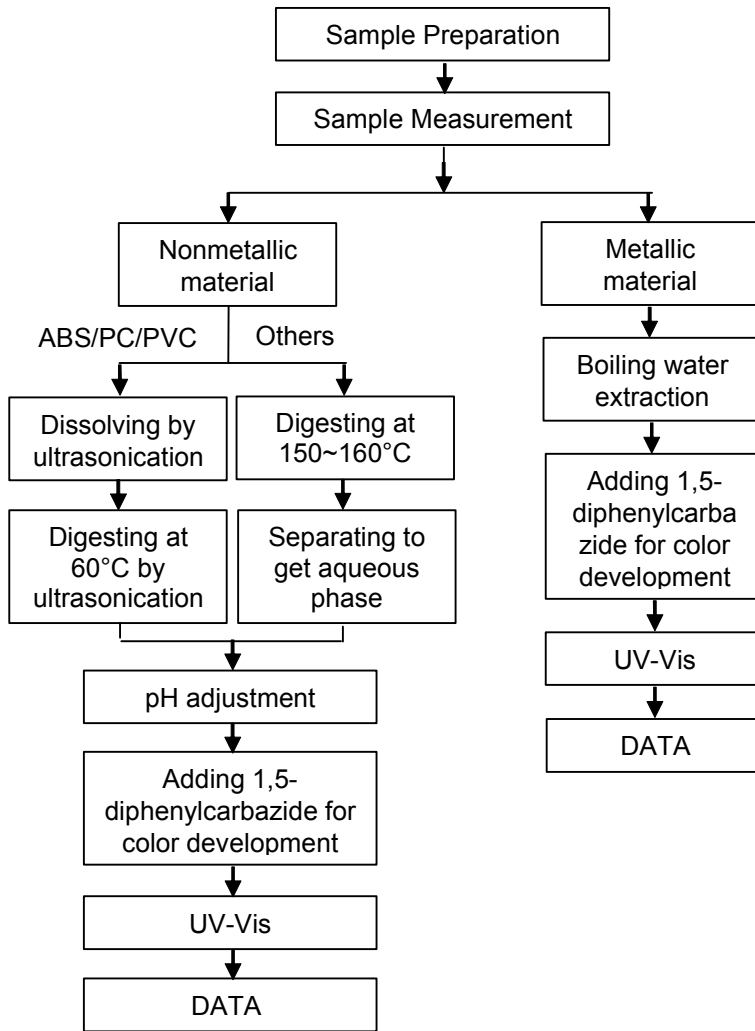
### Phthalates Testing Flow Chart

Hexavalent Chromium (Cr(VI)) Testing Flow Chart



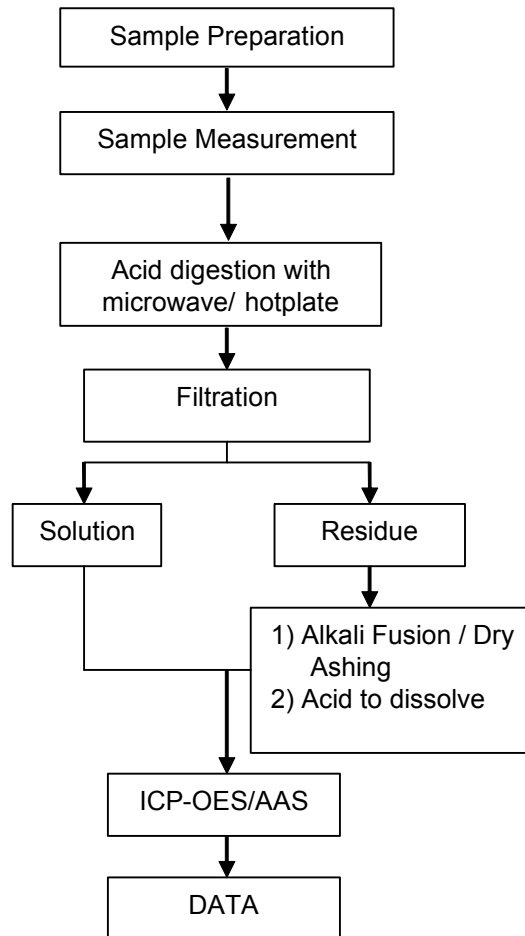

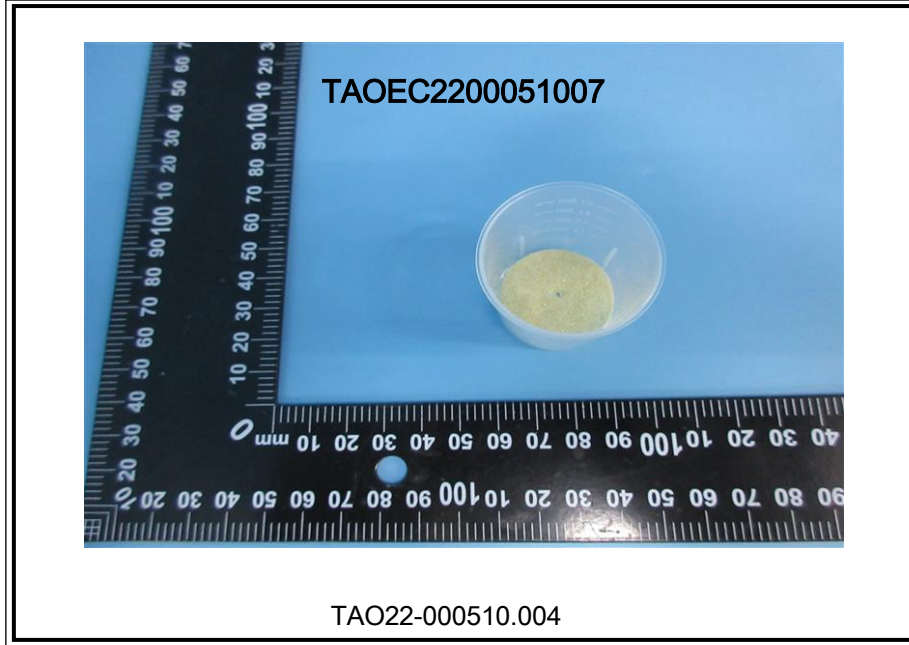
**Elements (IEC62321) Testing Flow Chart**
